

As announced on November 6, 2023 URGENT: MEDICAL DEVICE RECALL

0.9% Normal Sterile Saline for Irrigation USP, Sterile Water for Irrigation USP, and Sterile Saline Spray Cans

Dear Device Customer/Distributor,

Purpose of this letter:

The purpose of this letter is to advise you that Nurse Assist, LLC is voluntarily recalling the following products indicated for moistening absorbent wound dressings and for moistening, debriding and cleaning acute and chronic dermal lesions, such as Stage I-IV pressure ulcers, stasis ulcers, diabetic ulcers, foot ulcers, post-surgical wounds, first and second degree burns, cuts, abrasions and minor skin irritations and for device irrigation. It is important that we coordinate this action with you. Key action items for you and for us are described below.

- 0.9% Normal Sterile Saline for Irrigation USP (100 mL bottles, 250 mL bottles, 500 mL bottles, 1000mL bottles, 3.1oz spray can, 7.1oz spray can, 3mL syringes, 5mL syringes, and 10mL syringes)
- Sterile Water for Irrigation USP (100 mL bottles, 250 mL bottles, 500 mL bottles, 1000mL bottles, 120 mL cups, 10mL syringes, and 30mL syringes)

Reason for the Voluntary Recall:

Nurse Assist has identified product in distribution for which the required sterility assurance level (SAL) of 10⁻⁶ cannot be guaranteed.

Risk to Health:

According to the U.S. Centers for Disease Control and Prevention (CDC), the effects of specific bioburden on people "vary widely, ranging from no symptoms at all to serious infections". Possible contaminants pose little medical risk to healthy people and use on intact skin, but people who have certain health problems like weak immune systems, who are otherwise susceptible to infection or chronic lung diseases may be more susceptible. Some of the risks include blood stream infections, urinary tract infections or respiratory infections and in the worst-case scenario sepsis and death.

How to recognize that the device may fail:

It is not possible to recognize this potential device failure.

Urgent Actions Items for Customers/Distributors:

- "Devices that have been shipped to your facility" should be immediately taken out of use and quarantined.
- A Returned Goods Authorization will be provided by Nurse Assist, LLC to facilitate the return of the product. This may involve products already in the distribution chain.

- Immediately notify your customers by sending the attached recall notification to all customers who have received "Devices that have been shipped to your facility". This notice instructs customers to return any affected devices to their distributor.
- Please follow up with customers to ensure they received the recall notification and are taking appropriate action.
- Please make every effort to retrieve any of these unused products from your customers and complete and return the attached MEDICAL DEVICE RECALL RETURN RESPONSE FORM. Forms should be emailed or faxed to RQA, Inc. (a third-party recall provider) at nurseassist@rqa-inc.com or faxed to 844-329-2772.
- Please provide a "Customer Shipment Report" that lists all devices shipped to customers. The report should include the Shipment Date, Customer Name and Address, Part Number, Lot Number, and Quantity. This information is important to determine removal effectiveness.
- Please complete Attachments of Acknowledgement and Product Replacement Forms (separate sheets) and return to RQA, Inc.
- We have reported this recall to the applicable regulatory agencies. If your company repacked these medical devices into convenience kits, please contact your local FDA recall coordinator to evaluate the need for a new recall.

Nurse Assist, LLC Actions:

- Provide Initial FSCA Report to regulatory authorities. Expected by November 17, 2023.
- Address any concerns regulatory authorities may have. Issue Follow-Up Reports as needed.
- Monitor progress of device removal. Follow-up with distributors and customers as needed.
- Provide Final FSCA Report to regulatory authorities.
- Nurse Assist has determined the root cause to be prolonged exposure of the bottled product to the induction sealing process, causing the lift and peel tab adhesive to degrade.
- Nurse Assist has implemented a 100% visual verification of the induction sealing process, along with sampling after the induction sealing process for vacuum leak testing of the sterile barrier.
